Opening Comments, Harold Parker, Jr., Chair

Thanked everyone for taking the time to come to the meeting and their contributions are so very appreciated.

MBE/Section 3, Colene Orsini, VP of Procurement

- MBE/Section 3 goal is 30% and has been exceeded and is at 32.42%.
 - o MBE Contractor Payments are at 32.42% (goal is 30%).
 - o Women Contracting Payments are at 12.15% (goal is 10%).
 - o Section 3 Contractor Payment Services are at 25.48% (goal is 10%).
 - o Small Business Payments so far this year are at 26%.
- The Committee is requesting to raise the Section 3 goal to 25% to match what HUD requires and to also increase the MBE goal. Tonise Webb will draft a resolution with proper language to go before the full board.

Motion: (Jackson/Parker) to move sending to the full board for approval of a resolution to be drafted for raising the Section 3 goal to 25% to match what HUD requires as well as raising the MBE goal.

MBE Participation Report

- Meet and greet was held and there were 24 attendees at the event.
- Subcontractor outreach was held where 28 minority contractors attended the event.
- There is about 30% MBE response with Phase A meeting and exceeding the MBE requirement at 34% with a high Hispanic portion).

Results vs Plan and Future Opportunities

- African/American contractors have bid, but the bids were very high, so this has resulted in lower numbers with the infrastructure portion.
- More info is going to be blasted out to make it loud and clear that opportunities are available, but bids have to be submitted.
- Ms. Washington has had talks with Ralph Stuckey about making the connection with Mr.
 Stuckey's group and using them and the contractor is agreeable.

JOC Program, Mike Kelly

- Mike Kelly spoke about the use of the JOC program and how this will help to fulfill the large vacancy rate.
- Mr. Kelly stated they are looking to bring on two very large contractors at \$500,000 each as this relates to the local hiring opportunities.
- This will be a great opportunity to be able to put folks to work faster and not necessarily have to go through the vetting process to procure jobs.
- A resolution concerning the JOC program was passed and a report at the next meeting would be great on how things are coming along.
