o RFP went out for 400 E. Grace Street on June 10th, and the last day to submit bids is June

17th. This will be a serious gut job.

o Security sweeps of the vacant buildings are being done daily.

o RFP for Fay Towers will be released by the Procurement Department on June 17th. Fay

Towers may be used as park of the relocation sites for Gilpin Court.

o Advertising for bids was discussed such as using Richmond Times Dispatch and the Free

Press. Now bids are listed through EVA for the most part.

o Efforts moving towards a master development agreement for Gilpin with HRI is moving

forward. A briefing will be provided at next month's meeting.

o Discussion was had concerning a possible training site for residents.

o Discussion was had regarding the possible CNI grant that RRHA would like to qualify for

but there are certain requirements that need to be met.

Presentation Tax Exempt Revenue Bond Program

Mr. Graff gave a presentation explaining the Tax-Exempt Revenue Bond Program which

will give RRHA a lot of opportunities in the future. There are a lot of nice features but the number

one is there is no cost to the housing authority. CEO Nesmith will be bringing a one pager to the

board with language that will make it more attractive to get more developers coming in.
